Please fill out and return with a drawing or photos of your work area. **Please include on the drawing and request form, details of exactly where the lines that need to be covered are located and where any equipment will be set-up (i.e. scaffolding, lifts, ladders, etc.).** Powerline Utilities needs to be aware of the distances that you will be working from the wires and the measurements of the equipment to be used. Drawings can be hand drawn and need to show the work area. If your form is not filled out correctly a proper estimate cannot be provided and your form will be returned to you. Powerline Utilities will determine the length of the wire that needs to be covered based on the information that you have provided.

Please note, if you require service work on the property before the line protection can be installed you must call Toronto Hydro at 416-542-8000.

After submitting your request, please allow up to 5 business days to receive your contract. Once we receive the signed contract back, the line protection will be installed within 15 business days, or 1-2 business days if you have paid the 20% surcharge.
